## Dissertation:

---

My dissertation, “Unbecoming Romans,” consists of a series of case studies on Romanness as an ethnic identity at the geographic edges of the Roman state - or Romanía. It investigates the extent to which the inhabitants of these regions identified as and were accepted as members of a larger community of Romans, and it uncovers reasons why this identity might be accepted or denied by others. It finds that many of those who lived at the margins of Romanía self-identified as Romans, but whether or not this was understood by others depended upon the specific context of the observer.
