Established in 2018, the Curtin Open Knowledge Initiative (COKI) combines Humanities perspectives with deep data science. COKI has drawn together more than 1.2 trillion elements of data relating to Australian research outputs, funders, accessibility, collaborations and impacts. As co-founder of COKI I have established a research program that addresses the information needs of policy makers, funders, and senior leaders; and supports the translation of research into innovation for communities and industry. I have secured more than \$3.5 million in external project funding; and built a high-performing team of more than 15 researchers and data scientists.
