Translating Hell: Vernacular Theology and Apocrypha in the Medieval North Sea (Under Contract, Manchester University Press)

In the Middle Ages, hell could be useful because it was vaguely defined. The canonical scriptures only mention the concept a handful of times, leaving much to the imaginations of early Christians, who used the space to work out who did and did not belong to the faith. This book tells the story of how hell was used in the Middle Ages to experiment with local issues in theology and identity across the North Sea region. Examining vernacular translations of two popular apocryphal hell texts, the book argues that they were often used as experimental spaces because of their liminal textual authority. Since apocrypha are noncanonical scriptures, the genre allowed medieval writers to revise their hells (since they were not actually scripture), while also encouraging later readers to revere those experimental hells as valid (since they *seemed* like scripture). The book studies adaptations and experiments from early Medieval England, Iceland, Ireland, and Wales, placing the vernacular theologies of the North Sea in comparative conversation, and highlighting how Northern Europe contributed to the evolution of hell as much as did regions to the south and east.
